
- Today's young adults with cochlear implants are the first generation of children who were implanted under the age of 18




A GLIMPSE OF OUR LIVES...

- "Declaring our group as Young Adult CI Users as a primary stakeholder that the world needs to support us and our needs"
- "Lack of Understanding of the needs of Young Adult CI users in the everyday life"

OUR REALITY

- "As a cochlear implant user participating and active in the hearing world, my deafness is more hidden... I find my deafness can be seen as 'fixed', which means that discrimination can happen without people even realising they are doing it... because they can easily assume I can hear and brush my needs under the carpet."
- "Lack of understanding that I DO still need additional supports and accommodations to support my needs as Young Adult with CIs... I hear and speak "too well" therefore I "don't really need those supports"..."
- "All the while, we could be deaf again in a snap. It's frightening and hard to think about."
- "(We need to declare) the unique placement of CI users in society and how their communication needs differ depending on the circumstances in which they are in."
- "... we are a stakeholder group, and we must be recognized. Our voices must be heard and must be respected. Our lived experiences are valuable, and we DO bring meaningful considerations to the table that should be considered whether it's considerations related to education, work accessibility, CI care/technology development, healthcare, etc.,... (the world) do not think of Young Adults who use CIs that likely also identify as d/Deaf."

LACK OF ACCESS TO CI CARE

- "Once implanted, especially at young ages, there are life long costs associated with mapping, repairs or replacing parts and the event that the processor is damaged or lost and since being implanted so young it's very possible there could be a need for re-implantation if the device fails after 30-40 years or longer.
- "(There is a) lack of understanding of our needs as Young Adults with CIs, lack of advocacy for our needs and sharing the benefits of regular CI mapping for hearing & life quality of life to public & other Young adults with CIs, and significant financial burden for Young Adults with CIs due to high costs."
- "Many people get their cochlears later in life when they may have 20 years to live or less but not me I may have mine for 80 or more years. I've already had them 19 years so I'm facing struggles and issues the older generation knows nothing about..."



"I will have CIs all my life. I SHOULD HAVE SUPPORT FOR THEM ALL MY LIFE."
